Real-Time Trading Rewards for Standard Account

Promotion Dates: April 1, 2025 – July 31, 2025

1. **Eligibility:** This promotion is only available to CWG Standard Accounts.
2. **Trading Rewards Details:** During the promotion, CWG Standard Account holders can earn trading rewards for every trade they make. If multiple standard accounts are opened under the same CID, each account will independently calculate the number of trades and rewards, as follows:
 - A single standard account cannot receive rewards for the first 5 traded lots.
 - For monthly trading volumes over 5 standard lots, each additional lot is qualified for \$1.
 - For monthly trading volumes over 25 standard lots, each additional lot earns \$2.

(Trading lots are automatically reset to zero on the last day of each month and accumulate the following month.)

Example:

- Customer A trades 5 lots per month and is not qualified for the trading reward.
 - Customer B trades 15 standard lots per month, with 10 lots qualifying for trading reward, resulting in a total money back of \$10.
 - Customer C trades 50 standard lots per month, with 20 qualifying for \$1 per lot rewards and 25 qualifying for \$2 per lot rewards, summing \$70 in money back.
3. **Real-Time Credit:** Trading cashback is automatically credited to the wallet of the Client Zone within 5-10 minutes after closing the position.
 4. **Eligible Trades:** The PAMM account cannot participate in this campaign. Rewards are only available for forex, gold, and silver trades; other trading products are not included. Trades will not be calculated if orders close within 3 minutes.
 5. **Fraud Prevention:** During the promotion, if participants engage in any fraudulent activities, such as trading with accounts using the same IP address simultaneously, or using multiple accounts (including but not limited to CWG internal accounts or accounts from different brokers) for related trading, arbitrage, malicious hedging, high-frequency trading arbitrage, quote delay arbitrage, or if more than 70% of the trading volume of participating accounts is

concentrated in specific products or maintains a fixed trading direction, or any other improper trading methods, CWG reserves the right to disqualify the participant, cancel the promotion eligibility, reclaim any improper profits, and terminate the business relationship with the customer.

6. **Combination with Other Promotions:** This promotion can be combined with all other CWG promotions.
7. **Rights to Modify:** CWG reserves the right to change the terms of the promotion or cancel the promotion at any time.

This promotion is hosted by CWG Markets (VFSC), and CWG Markets (VFSC) owns the final interpretation rights.
