



COPY TRADE USER AGREEMENT

These terms of service are the agreement between you and CWG Markets Ltd. This clause can be amended as necessary without further notice. The revised terms will effectively replace the original terms of service once published on the website.

1. ACCOUNT

CWG Markets copy trade community is an innovative trading community. When CWG Markets receives the trading signal from the signal provider, it will confirm whether it is consistent with the margin distribution or the number of lots in the follower account. If the signal is accepted, the CWG copy trade system will synchronously and automatically execute the merchandiser orders for the copy trade account.

Before using the CWG Markets copy trade community, you need to register your CWG Markets copy trade account. You will also you need to carefully read the privacy policy and risk disclosure of CWG Markets and submit the necessary personal and team information to complete the registration after fully reading and understanding the relevant agreements. Any information related to yourself obtained by CWG Markets will be used safely in accordance with the relevant provisions of the privacy policy.

Your registered account is managed and used by you, but it still belongs to CWG Markets. Unless you violate the relevant provisions of the privacy policy, CWG Markets will permanently retain your right to use your registered account.

Please keep your account name and password safe and secure. After you use it, you should exit safely. Due to your poor custody, you may suffer from number theft or password theft, and the responsibility shall be borne by yourself.

2. Use of service

The following actions are prohibited:
