



CWG Markets Prime Bonus

Event Time: November 1, 2025 - November 30, 2025

1. This promotion is open to CWG Standard Account, ECN Account, and existing Speed Account holders.
2. During the event period, each CID can apply for the Prime Bonus only once per calendar month. The bonus amount is listed in the table below. After successfully applying, the bonus will be converted into own funds upon completing the required lot size.

***When clients use U-Coin for deposits to participate in this promotion, the promotional benefits will be calculated based on 110% of the Deposit amount. For example, if the deposit is 9,100 USD, the actual amount eligible for the promotion will be: $9,100 * 110\% = 10,010$ USD, which means a maximum bonus of 1,000 USD can be applied for.**

3. The lot size for this promotion only counts for Forex, Gold, and Silver. Trading volume of other products will not be included in the valid lot size.
4. After applying for the Prime Bonus, it will be credited to the trading credit. Before the required lot size is completed, the Prime Bonus can cover positions but cannot absorb losses. Once the required lot size is completed and the application is submitted, the bonus will be transferred to the account balance, and it can be freely traded or withdrawn.
5. If the net value of the promotional account falls below 120% of the Bonus amount during the event period, the bonus will be automatically deducted. If this occurs within the 30-day trading period, the



client can make a new deposit to restore the account balance to at least the Bonus amount and apply to have the bonus reinstated.

Restoration process: The applicant should send their name, trading account, Deposit amount, and Prime Bonus restoration request from their registered email address to the designated event email:

6. The Prime Bonus is valid for 30 days after the bonus is credited. After the expiration period, the bonus will be automatically deducted.
7. The Prime Bonus can only be applied once per trading period. New deposits for bonus applications can only be made after the previous round's trading requirements have been completed.
8. Any fluctuations in positions or financial losses caused by the deduction of insufficient or expired bonuses will be borne by the client. CWG assumes no responsibility.
9. Other promotional accounts are free to deposit and withdraw, but for accounts participating in the Prime Bonus, if there are transfers or withdrawals before the required lot size is completed during the trading period, the bonus will be automatically deducted and cannot be reinstated.
10. PAMM accounts are not eligible for this promotion. If an account that has applied for a bonus is later added to a PAMM account, the bonus will be revoked.
11. Orders placed within 3 minutes of opening or closing will not count towards the lot size.

 - B. Once the trading requirements are met, CWG will complete the review within 3 business days, and the eligible bonus will be automatically transferred to the account balance.
 - C. After the bonus expires, it will be automatically removed. If you wish to cancel the promotion early, please go to **【Client Area - Activity Center - Prime Bonus - Bonus Application】** and click "Cancel

Bonus." CWG will assist in withdrawing the entire bonus within 1 business day. Once withdrawn, the bonus cannot be reinstated.
